**Invitation to Bid for Provision of Visiting Area
And Admin Building at Virac District Jail**
Reference No. IB5-003-2014

1. The Bureau of Jail Management and Penology Region V (BJMP-RV), through the General Appropriations Act (GAA) FY 2014 intends to apply the sum of SEVEN HUNDRED THOUSAND PESOS (Php 700,000.00) being the Approved Budget for the Contract (ABC) to payments under the contract for Provision of Visiting and Admin Building at Virac District Jail/Contract No. CW5-003-14. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The BJMP-RV now invites bids for the construction of a two (2) storey building intended for visiting area at the ground floor and administrative office at the second floor at Virac District Jail. Completion of the Works is required within One Hundred Twenty (120) Calendar Days. Bidders must have an experience of having completed, at least One (1) Contract similar to the project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

4. Interested bidders may obtain further information from BJMP-RV BAC Secretariat and inspect the Bidding Documents at the address given below during Office Hours (8AM to 4PM).

A complete set of Bidding Documents may be acquired by interested Bidders on *March 7 to March 19, 2015* from the address below and upon payment of a nonrefundable fee for the Bidding Documents pursuant to the latest Guidelines issued by the GPPB, in the amount of Seven Hundred Pesos (Php 700.00).

It *may also be downloaded* free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that bidders shall pay the fee for the Bidding Documents not later than the submission of their bids.

5. Bids must be delivered to the address below on or before *19 March 2015 at 2 o'clock in the afternoon* at *BJMP Regional Office 5, Legaspi City Jail Compound, Bogtong, Legaspi City*. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

6. *It is the sole responsibility of the bidder to know the process to undertake as stated in the bidding documents and in the applicable laws pertaining to the bidding process.*
7. The *BJMP-RV* reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
