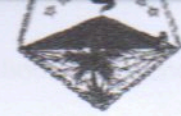

**Invitation to Bid for
Construction of Jail Building Annex at
Naga City District Jail
Reference No. IB5-001-2015**

1. The Bureau of Jail Management and Penology Region V (BJMP-RV), through the General Appropriations Act (GAA) FY 2015 intends to apply the sum of ONE MILLION ONE HUNDRED THOUSAND PESOS (Php 1,100,000.00) being the Approved Budget for the Contract (ABC) to payments under the contract for Construction of Jail Building Annex at Naga City District Jail/Contract No. CW5-001-15. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The BJMP-RV now invites bids for the construction of jail building annex intended for residents of Naga City District Jail consisting of two (2) cell dorms with toilet and bath. Completion of the Works is required within One Hundred Twenty (120) Calendar Days. Bidders must have an experience of having completed, at least One (1) Contract similar to the project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

4. Interested bidders may obtain further information from BJMP-RV BAC Secretariat and inspect the Bidding Documents at the address given below during Office Hours (8AM to 4PM).
5. A complete set of Bidding Documents may be purchased by interested Bidders on *June 15 to 13 July 2015* from the address below and upon payment of a nonrefundable fee for the Bidding Documents in the amount of One Thousand Pesos (Php 1,000.00).

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that bidders shall pay the fee for the Bidding Documents not later than the submission of their bids.


6. The *BJMP-RV* will hold a Pre-Bid Conference on *30 June 2015* at *BJMP Regional Office 5, Legaspi City Jail Compound, Bogtong, Legaspi City*, which shall be open only to all interested parties who have purchased the Bidding Documents.
7. Bids must be delivered to the address below on or before *13 July 2015 at 2 o'clock in the afternoon* at *BJMP Regional Office 5, Legaspi City Jail Compound, Bogtong, Legaspi City*.

All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

8. It is the sole responsibility of the bidder to know the process to undertake as stated in the bidding documents and in the applicable laws pertaining to the bidding process.
9. The *BJMP-RV* reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
