Invitation to Bid for
Rehabilitation of Perimeter Fence at
Placer District Jail
Reference No. IB5-002-2015

1. The Bureau of Jail Management and Penology Region V (BJMP-RV), through the General Appropriations Act (GAA) FY 2015 intends to apply the sum of TWO MILLION PESOS (Php 2,000,000.00) being the Approved Budget for the Contract (ABC) to payments under the contract for Rehabilitation of Perimeter Fence at Placer District Jail/Contract No. CW5-002-15. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The BJMP-RV now invites bids for the rehabilitation of Placer District Jail's perimeter fence. Completion of the Works is required within One Hundred Twenty (120) Calendar Days. Bidders must have an experience of having completed, at least One (1) Contract similar to the project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instruction to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

4. Interested bidders may obtain further information from BJMP-RV BAC Secretariat and inspect the Bidding Documents at the address given below during Office Hours (8AM to 4PM).
5. A complete set of Bidding Documents may be purchased by interested Bidders on *June 15 to 13 July 2015* from the address below and upon payment of a nonrefundable fee for the Bidding Documents in the amount of One Thousand Pesos (Php 2,000.00).

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity,


provided that bidders shall pay the fee for the Bidding Documents not later than the submission of their bids.

6. The BJMP-RV will hold a Pre-Bid Conference on *30 June 2015* at 3 o'clock in the afternoon at BJMP Regional Office 5, Legaspi City Jail Compound, Bogtong, Legaspi City which shall be open only to all interested parties who have purchased the Bidding Documents.
7. Bids must be delivered to the address below on or before *13 July 2015* at 2 o'clock in the afternoon at BJMP Regional Office 5, Legaspi City Jail Compound, Bogtong, Legaspi City. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

8. It is the sole responsibility of the bidder to know the process to undertake as stated in the bidding documents and in the applicable laws pertaining to the bidding process.
9. The BJMP-RV reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
