PROCUREMENT CONTRACT

This CONTRACT, is entered this **MAR 04 2016** day of _____ 2016, by and between:

The **BUREAU OF JAIL MANAGEMENT AND PENOLOGY**, Government Agency of the Philippines, with principal address at 144 Mindanao Avenue, Project 8, Quezon City, represented by **J/CSUPT DEOGRACIAS C TAPAYAN, OIC, BJMP**, hereinafter referred to as the "Entity".

and


The **EXCELLENT GENERAL SERVICES, INC.**, with business address at 28 Evangeline Reyes Street, BF Resort Village, Talon II, Las Piñas City, represented by **Ms. Gina O. Ramos, President and General Manager**, hereinafter referred to as the "Supplier".


WHEREAS, the ENTITY is desirous of the **Procurement of Janitorial and Building Maintenance Services** (hereinafter called "Goods") and ENTITY has accepted the bid of One Million Four Hundred Ninety Nine Thousand Nine Hundred Ninety Eight Pesos and Ninety Two Centavos (Php 1,499,998.92) by the SUPPLIER for the start of delivery of such goods within Forty Five (45) Calendar Days upon receipt of the Notice to proceed (NTP).

THE PARTIES HEREBY AGREED TO THE TERMS STATED HEREUNDER:

 - h. Performance Security;
 - i. Notice of Award of Contract and the bidder's conforme thereto;
 - j. Other contract documents that may be required by existing laws and/or the ENTITY.



3. THAT in consideration of the payments to be made by the ENTITY to the SUPPLIER as hereinafter mentioned, the SUPPLIER hereby covenants with the Entity to execute and complete the delivery of Goods and remedy any defects therein in conformity with the provisions of this Contract and the relevant provisions on Obligations and


Contracts (Book IV, Titles I and II) and Sales (Book IV, Title VI) of the Civil Code of the Philippines;
