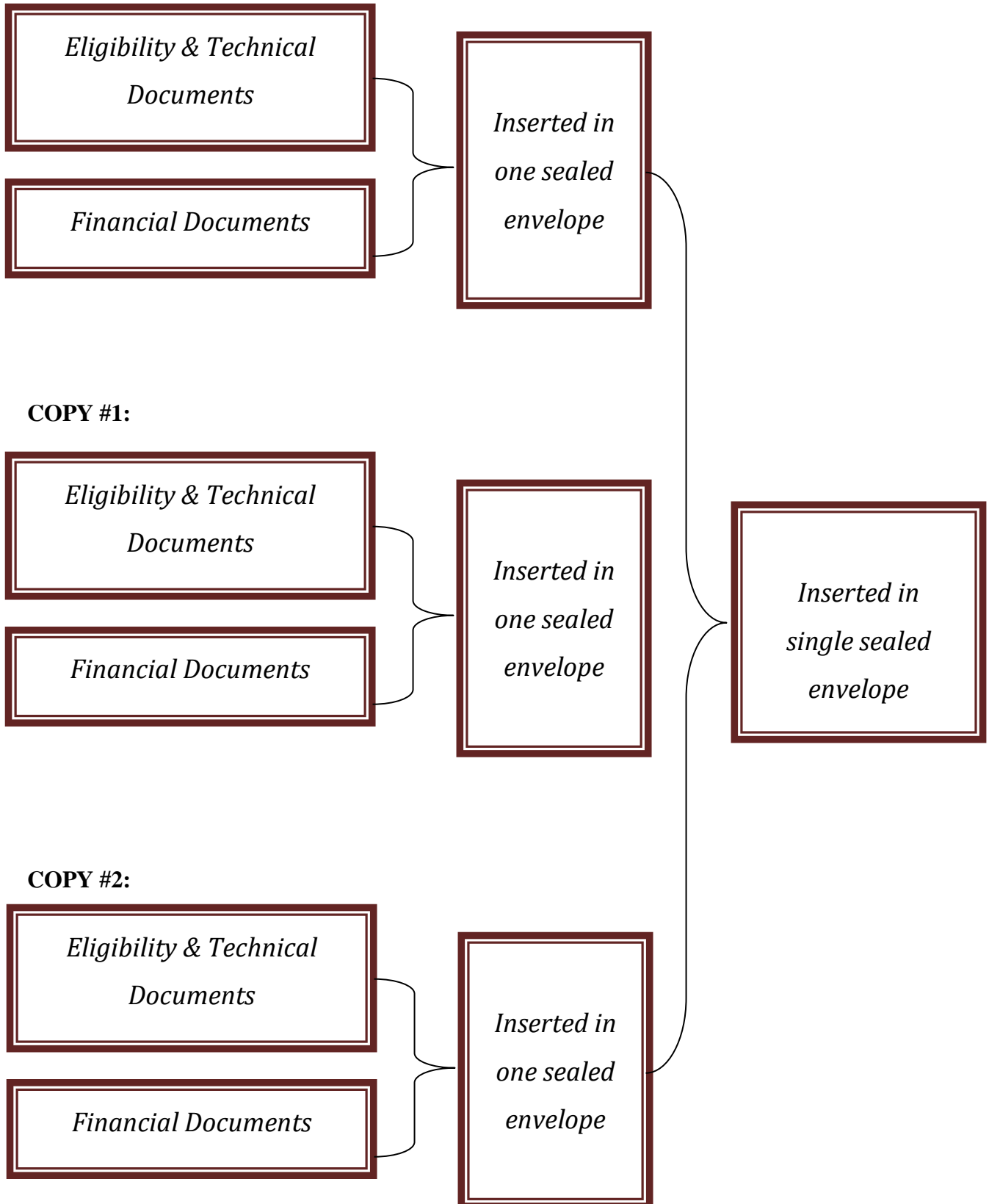

## **DOCUMENTS TO BE SUBMITTED**

### **(First Envelope - *Eligibility/Technical*)**

#### **I. Eligibility Documents:**

##### **A. Class “A” Documents:**

- a. Registration certificate from the Securities and Exchange Commission (SEC), Department of Trade and Industry (DTI) for sole proprietorship, or Cooperative Development Authority (CDA) for cooperatives.
- b. Mayor’s permit issued by the city or municipality where the principal place of business of the prospective bidder is located
- c. Statement of all its ongoing government and private contracts, including contracts awarded but not yet started, if any, whether similar or not similar in nature and complexity to the contract to be bid. Use the form prescribed in Section IX, Bidding Forms.
- d. Statement identifying the bidder’s single largest completed contract similar to the contract to be bid. Use the form prescribed in Section IX, Bidding Forms.
- e. Valid Philippine Contractors Accreditation Board (PCAB) license and registration for the type and cost of the contract for this Project
- f. Audited financial statements, showing, among others, the prospective total and current assets and liabilities, stamped “received” by the BIR or its duly accredited and authorized institutions, for the preceding calendar year which should not be earlier than two (2) years from the date of bid submission
- g. NFCC computation in accordance with ITB Clause 5.5. Use the form prescribed in Section IX, Bidding Forms; and
- h. Tax Clearance per Executive Order 398, Series of 2005, as finally reviewed and approved by the BIR.

##### **B. Class “B” Documents:**

Valid Joint Venture Agreement (JVA) if applicable. *In case of Joint Venture, the bidder must present a valid Special PCAB License in accordance with Section 3.5 of IRR of RA 4566 for the Joint Venture, in addition to the valid individual PCAB license of both partners.*

*If Joint Venture is not applicable, submit a statement of “NOT APPLICABLE” in lieu of the foregoing.*
