**Invitation to Bid for the Construction of Jail Building of  
 Imus City Jail**

(BJMP NHQ - IB No. W014-2016)

The Bureau of Jail Management and Penology (BJMP), through the General Appropriations Act of 2016 intends to apply the sum of **Thirty One Million Forty Thousand Pesos (Php 31,040,000.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for the **Construction of Jail Building of Imus City Jail under BJMP NHQ -IB No. W014-2016**. Bids received in excess of the ABC shall be automatically rejected at bid opening.

1. The BJMP now invites bids for the above-named project described as follows:

Description of Works	<p>The project involves the construction of Thirty-Two (32) cells which includes the following scope of works:</p> <ul style="list-style-type: none"> <li>a. Mobilization</li> <li>b. Demobilization</li> <li>c. Temporary Facilities</li> <li>d. Billboards &amp; Signage</li> <li>e. Site Clearing/Preparation &amp; Layout</li> <li>f. Soil Investigation</li> <li>g. Permits &amp; Clearances</li> <li>h. Excavation &amp; Backfilling</li> <li>i. Reinforced Concrete Works</li> <li>j. Masonry Works</li> <li>k. Electrical Works</li> <li>l. Plumbing Works</li> <li>m. Formworks &amp; Scaffoldings</li> <li>n. Water Proofing</li> <li>o. Metal Works</li> <li>p. Installation of PVC Doors</li> <li>q. 2. Completion of the Works is required for **Three Hundred Sixty (360) Calendar Days**. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.



3. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act".
4. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.
5. Interested bidders may obtain further information from *Directorate for Logistics, BJMP-NHQ at 144 Mindanao Avenue, Project 8, Quezon City* and inspect the Bidding Documents at the address given below from *8:00 AM to 5:00 PM, Mondays to Fridays starting October 10, 2016*.
6. A complete set of Bidding Documents may be acquired by interested Bidders from the address below and upon payment of a nonrefundable fee for the Bidding Documents, pursuant to the latest guidelines issued by the GPPB, in the amount of *Twenty Three Thousand Pesos (Php 23,000.00)*.
7. It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that bidders shall pay the fee for the Bidding Documents not later than the submission of their bids.
8. The *BJMP* will hold a Pre-Bid Conference on *October 18, 2016 at 1:00 PM at BJMP Conference Room, 144 Mindanao Avenue, Project 8, Quezon City*, which shall be open only to all interested parties.
9. Bids must be delivered to the address below on or before *November 3, 2016 at 4:00 PM at BJMP Conference Room, 144 Mindanao Avenue, Project 8, Quezon City*. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

10. The *BJMP* reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
