RESOLUTION No. G-2016-013

A Resolution Recommending to the Officer-in-Charge, BJMP the Declaration of Single Calculated and Responsive Bid and Award of Contract to SPARTANS 3 TRADING CORP. for the SUPPLY AND DELIVERY OF 1,200 UNITS OF HANDCUFFS THROUGH REBIDDING

WHEREAS, the Bureau of Jail Management and Penology, sought to improve its restraint capabilities;

WHEREAS, in pursuance of this objective, the agency has included in its Annual Procurement Plan (APP) for CY 2016, the procurement of 1,200 units Handcuffs;

WHEREAS, the Technical Working Group with members of the BJMP-NHQ BAC conducted a series of meetings and a pre-procurement conference to assess the readiness of the procurement activity;

WHEREAS, the Invitation to Bid (ITB) for the Supply and Delivery of 1,200 Units of Handcuffs under Bid Reference No. G-2016-002 was published at Phil GEPS (*Annex "A"*), BJMP websites, and at the Logistics Bulletin Board (*Annex "B"*) to invite interested bidders to undertake the project, as well as to request the presence of observers and representatives from the Commission on Audit and Department of the Interior and Local Government (*Annex "C"*).

WHEREAS, during the pre-bid conference (*Annex "D"*), the BAC was informed that nobody purchased the bidding documents and, as such, no bidder was present. In attendance only were the representatives of Undersecretary for Public Safety, Department of Interior and Local Government and the Commission on Audit;

WHEREAS, on the first submission and opening of bids (*Annex "E"*) which was held on 08 December 2015, no bidder submitted a bid and as such, the BAC declared a **failure of bidding**;

WHEREAS, Spartans 3 Trading Corp. participated during the second opening of bids (*Annex "F"*) which was held on 17 February 2016;

WHEREAS, upon scrutiny of the documents submitted, it was found that the Technical Documents of the bidder only includes the List of Ongoing Projects and List of Completed Projects of one of the parties to the joint venture. As such, the BAC considered the bid as **"failed"**;

WHEREAS, Spartans 3 Trading Corp. submitted a Motion for Reconsideration (*Annex "G"*) which the BAC decided to **grant** in a meeting conducted on 23 February 2016 (*Annex "H"*) and was accordingly relayed to it in a letter dated 24 February 2016 (*Annex "I"*);

WHEREAS, on the continuation opening of bids on 15 March 2016 (*Annex "J"*)

the bid of Spartans 3 Trading Corp. was declared as "passed" after the BAC evaluated the eligibility and technical components of the lone bidder;

WHEREAS, Spartans 3 Trading Corp. on its part submitted a bid security in the form of the Bid Securing Declaration. The bid amounts to **FIVE HUNDRED NINETY-EIGHT PESOS ONLY (PHP 598,800.00)**.




WHEREAS, during the conduct of the post-qualification, all authenticated documents submitted were verified and found to be the same as with the originals in the possession of the contractor;
