A RESOLUTION RECOMMENDING TO THE CHIEF, BJMP THE DECLARATION OF LOWEST CALCULATED AND RESPONSIVE BIDDER AND AWARD OF CONTRACT FOR THE SUPPLY AND DELIVERY OF 36 UNITS PRISONERS VAN (REBIDDING)

WHEREAS, the Bureau of Jail Management and Penology aims to improve its capability requirements;

WHEREAS, in pursuance of this objective, the bureau has included in its Annual Procurement Plan (APP) for CY 2016, the procurement of thirty six (36) units of prisoners van;

WHEREAS, the BJMPBAC together with the Technical Working Group conducted a pre-procurement conference to assess the readiness of the procurement activity;

WHEREAS, the Invitation to Bid (ITB) for the Supply and Delivery of 36 Units Prisoners Van (Rebidding) with an **Approved Budget for the Contract (ABC)** amounting to **Thirty Three Million Four Hundred Fifty Six Thousand Pesos (Php 33,456,000.00)** was published at PhilGEPS (Annex "A") and BJMP websites and at the Logistics Bulletin Board (Annex "B") to invite interested bidders to undertake the project, as well as to request the presence of observers and representatives from the Commission (COA) on Audit, Philippine Chamber of Commerce and Industry (PCCI) and People Power Volunteers for Reform (PPVR) (Annex "C");

WHEREAS, a pre-bid conference (Annex "D") on this project was conducted on March 28, 2017 with the presence of representative/s of the prospective bidders and observers from COA and PPVR. Said conference yielded positive responses from the prospective bidders and likewise, the TWG of this project have answered various questions and requests for clarifications to address fully the concerns of the prospective bidders on this project;

WHEREAS, submission and opening of bids (Annex "E") was held on April 10, 2017 wherein a lone bidder, **Diamond Motors Corporation**, submitted bidding documents. After the TWG evaluated the eligibility and technical components of the bidders, the lone bidder passed and complied all legal and technical components as well as financial components of this project. Relative thereto, Diamond Motors was declared **Single Calculated Bidder (SCB)** with the **bid offer amounting to Thirty Three Million Two Hundred Ninety One Thousand Eight Hundred Seven Pesos and Forty Eight Centavos (Php 33,291,807.48)**. and submitted Bid Security in a form of Surety Bond;

WHEREAS, the TWG conducted Post Qualification Process (Annex "F") and found the lone bidder to be compliant and have passed all necessary testing requirements of this project. Thus, the BAC declared **Diamond Motors Corporation** as
