**A RESOLUTION RECOMMENDING TO THE CHIEF, BJMP THE DECLARATION OF SINGLE CALCULATED AND RESPONSIVE BIDDER AND AWARD OF CONTRACT FOR THE SUPPLY AND DELIVERY OF DOCUMENT SCANNER UNDER THE PROJECT 3 FOR BJMP ISSP CY 2017 (57 SETS)**

**WHEREAS**, the BJMP have programmed various IT projects for CY 2016 under the **MITHI** (Medium-Term Information and Communications Technology Harmonization Initiative) an e-Government and ICT support initiative that aims to harmonize and ensure interoperability among ICT-related resources, programs, and projects across the government;

**WHEREAS**, the BJMPNHQ-BAC conducted pre-procurement conference to assess the readiness of the procurement activity;

**WHEREAS**, the Invitation to bid (ITB) for the procurement of Supply and Delivery of Document Scanner under Project 3 for BJMP ISSP CY 2017 (57 Sets) with an **Approved Budget for the Contract (ABC)** amounting to **One Million Five Hundred Ten Thousand Five Hundred Pesos (Php 1,510,500.00)** was published at Phil GEPS (Annex "A"), BJMP websites and at the Logistics Bulletin Board (Annex "B") to invite interested bidders to undertake the project, as well as to request the presence of observers and representative from the Commission on Audit, Philippine Chamber of Commerce and Industry and the People Power Volunteers for Reform (Annex "C");

**WHEREAS**, a pre-bid conference (Annex "D") on this project was conducted on July 19, 2017 with the presence of prospective bidders and observers from Commission on Audit and People Power Volunteers for Reform. Said conference yielded positive responses from the prospective bidders and likewise, the TWG of this project have answered various questions and requests for clarifications to address fully the concerns of the prospective bidders on this project;

**WHEREAS**, submission and opening of bids (Annex "E") was held on August 1, 2017 wherein three bidders submitted bidding documents namely, Pronet Systems Integrated Network Solutions, Inc, Microdata Systems Management Inc. and Floro International Corporation. After the initial evaluation, the TWG found all eligibility and technical components of both bidders to be compliant to the requirements of this project, hence all were **declared eligible**;

**WHEREAS**, financial documents submitted by the bidders were also evaluated by the TWG and both were declared passed. Pronet Systems Integrated Network Solution, Microdata Systems Management Inc. and Floro International Corporation submitted a bid offer amounting to Nine Hundred Forty Thousand Five Hundred Pesos (Php 940,500.00), Nine Hundred Ninety Nine Thousand Seven Hundred Ninety Nine Pesos and Ninety Five Centavos (Php 999,799.95) and One Million Three Hundred Eleven Thousand Pesos (Php 1,311,000.00), respectively, together with their bid securities in the form of Bid Securing Declaration;

**WHEREAS**, the TWG conducted Bid Evaluation (Annex "F") and declared Pronet Systems Integrated Network Solutions Inc as the Lowest Calculated Bidder (LCB) with a bid offer amounting to Nine Hundred Forty Thousand Five Hundred Pesos (Php 940,500.00);


