**Declaration of Single Highest Rated and Responsive Bid and Recommendation for Award of Contract of the Project Design and Development of BJMP's Jails Service Intelligence Operations Center (JS-IOC) Under Project 1 of the BJMP's ISSP for FY 2016**

**WHEREAS**, on August 31, 2017, the BJMP Head of the Procuring Entity through its Bids and Awards Committee declared the consulting firm NEO-TECH ASIA DISTRIBUTION, Inc. – COMWORKS, Inc. as the Highest Rated Bidder (HRB) of the project Design and Development of BJMP's Jails Service Intelligence Operations Center (JS-IOC) Under Project 1 of the BJMP's ISSP for FY 2016;

**WHEREAS**, the BAC through its Secretariat invited NEO-TECH ASIA DISTRIBUTION, Inc. – COMWORKS, Inc. to the opening of its financial proposal on September 13, 2017;

**WHEREAS**, the BAC and NEO-TECH ASIA DISTRIBUTION, Inc. – COMWORKS, Inc. concluded the negotiations successfully;

**WHEREAS**, upon careful examination, validation and verification of all the eligibility, technical and financial requirements submitted by NEO-TECH ASIA DISTRIBUTION, Inc. – COMWORKS, Inc.; thus POST-QUALIFIED;


