A RESOLUTION RECOMMENDING TO THE CHIEF, BJMP THE DECLARATION OF SINGLE CALCULATED AND RESPONSIVE BIDDER AND AWARD OF CONTRACT TO ASCI-ESPINELI JOINT VENTURE FOR THE SUPPLY AND DELIVERY OF 215 UNITS HANDCUFFS

WHEREAS, the Bureau of Jail Management and Penology Bids and Awards Committee (BAC) through its Resolution No. G-2017-016 resolved to recommend to the Chief, BJMP that the Alternative Method of Procurement, particularly under 53.1 of the Revised Implementing Rules and Regulation (IRR) of Republic Act (RA) 9184, be resorted to in the procurement of project "Supply and Delivery of 215 Units of Handcuffs" as a result of two (2) failed biddings;

WHEREAS, the said recommendation was duly approved by the Chief, BJMP on June 6, 2017;

WHEREAS, from its original quantity of 250 units with an Approved Budget of the Contract of P 250,000.00 was reduced to 215 units to compensate in its specifications which is allowed under section 35.2 of the IRR of RA 9184;

WHEREAS, on September 9, 2017, the BAC through its Secretariat sent invitation/request for submission of proposals on the subject procurement to bona fide suppliers namely; ASCI - Espineli Joint Venture, Spartans 3 Trading Corp., and Shooters Guns & Ammos Corporation;

WHEREAS, in response to the invitation/request, only ARMSCOR Shooting Center Inc. – Espineli Joint Venture submitted its quotation/proposal and attended the opening of bids on October 9, 2017;

WHEREAS, during the bid opening, the bidders ASCI – Espineli Joint Venture passed the non-discretionary pass-fail eligibility criteria and was thus declared eligible;

WHEREAS, below is the result of the opening and evaluation of its financial proposal:

- 1. To declare AMSCOR Shooting Center Incorporated Espineli Joint Venture as the Single Calculated and Responsive Bidder for the Supply and Delivery of 215 units of Handcuffs; and
- 2. To recommend that the Supply and Delivery of 215 units of Handcuffs be awarded to ASCI - Espineli Joint Venture in the amount of P 249, 830.00:
