A Resolution Recommending the Declaration of Single Calculated and Responsive Bid and Award of Contract for the Supply and Delivery of 22 Units Prisoner's Van through Negotiated Procurement

WHEREAS, during the Bid Opening for the third renegotiation of the Supply and Delivery of 25 Units Prisoner's Van which was conducted on November 03, 2016, the BAC again declared a "failure" of bidding because no bidder was present (Annex "A");

WHEREAS, the TWG for Prisoner's Van conducted a mandatory review of the technical specification and other parameters of the project (Annex "B"); and the BJMPNHQ-BAC posted an Invitation to Bid (Annex "C") for the renegotiation of the Supply and Delivery of 22 Units Prisoner's Van;

WHEREAS, on the Bid Opening which was conducted on December 26, 2016, only one bidder submitted a bid;

WHEREAS, after the initial evaluation, the Technical Working Group found that the eligibility and technical components of Diamond Motors Corporation are all compliant;

WHEREAS, Diamond Motors Corp. submitted a bid security, in the form of the Bid Securing Declaration, and Surety Bond. The bid amounts to Php 20,481,044.32;

WHEREAS, during the conduct of the post-qualification, all authenticated documents submitted were verified and found to be the same as with the originals in the possession of the bidder;

NOW, THEREFORE, in view of the foregoing premises, the BJMP-NHQ Bids and Awards Committee resolves as it hereby resolved to declare DIAMOND MOTORS CORPORATION as the single calculated and responsive bidder and to subsequently award the contract for the SUPPLY AND DELIVERY OF 22 UNITS PRISONER'S VAN at its submitted bid price.


