

PROCUREMENT CONTRACT

This **CONTRACT**, is entered this 9th day of June 2017, by and between:

The **BUREAU OF JAIL MANAGEMENT AND PENOLOGY**, Government Agency of the Philippines, with principal address at 144 Mindanao Avenue, Project 8, Quezon City, represented by **J/DIR SERAFIN P BARRETTO JR, CHIEF, BJMP**, hereinafter referred to as the “**ENTITY**”.

and

The **PRONET SYSTEMS INTEGRATED NETWORK SOLUTION, INC.**, with business address at 3rd Floor, Hollywood Square Building #33 West Avenue, Quezon City; represented by **MS. HANNAH B. GONZALES, Account Manager**, hereinafter referred to as the “**SUPPLIER**”.

WHEREAS, the **ENTITY** is desirous of **Supply, Delivery, Installation, Testing and Commissioning of IP-PABX and Telephone Terminal (Re-bid)** (hereinafter called “Goods”) and has accepted the bid of **Seven Hundred Ninety-Six Thousand and Fifteen Pesos (Php796,015.00)** by the **SUPPLIER** for the supply and delivery of such goods for a period of sixty (60) calendar days upon receipt of the Notice to Proceed (NTP).

THE PARTIES HEREBY AGREE TO THE TERMS STATED HEREUNDER:

1. THAT in this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of the Contract hereinafter referred to;

2. THAT the following documents shall be attached, deemed to form and be read, construed as part of this Agreement, to wit:

- a. General and Special Conditions of the Contract;
- b. Specifications;
- c. Instructions to Bid;
- d. Instructions to Bidders;
- e. Bid Data Sheet;
- f. Bid Form, including all the documents/ statements contained in the Bidders bidding envelopes, as annexes;
- g. Eligibility requirements, documents and/or statements;
- h. Performance Security;
- i. Notice of Award of Contract and the bidder’s conforme thereto;
- j. Other contract documents that may be required by existing laws and/or the **ENTITY**.

3. THAT in consideration of the payments to be made by the **ENTITY** to the **SUPPLIER** as hereinafter mentioned, the **SUPPLIER** entered into covenants with the **ENTITY** to execute and complete the delivery of goods and remedy any defects therein in conformity with the provisions of this Contract and the relevant provisions on Obligations and Contracts (Book IV, Titles I and II) and Sales (Book IV, Title VI) of the Civil Code of the Philippines;

THAT the **ENTITY** hereby undertake to pay the **SUPPLIER** in consideration of the provision of the goods and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.
