 Bidding will be conducted through open competitive bidding procedures using a nondiscretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is open to all interested bidders, whether local or foreign, subject to the conditions for eligibility provided in the IRR of RA 9184.

- 4. Interested bidders may obtain further information from the BAC Secretariat, Bureau of Jail Management and Penology and inspect the Bidding Documents at the address given below during 8:00AM to 5:00PM (Monday to Friday).
- 5. A complete set of Bidding Documents may be acquired by interested Bidders on June 27, 2017 from BAC Secretariat (See Address Below) and upon payment of applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount indicated in the schedule.

Note: For lot procurement, the maximum fee for the Bidding Documents for each lot shall be based on its ABC, in accordance with the Guidelines issued by the GPPB; provided that the total fees for the Bidding Documents of all lots shall not exceed the maximum fee prescribed in the Guidelines for the sum of the ABC of all lots.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

- 6. The Bureau of Jail Management and Penology, National Headquarters will hold a Pre-Bid Conference⁴ on July 5, 2017 @ 9:00AM at BJMP Main Conference Room, 4th Floor BJMP Building, 144 Mindanao Avenue, Project 8, Quezon City, which shall be open to prospective bidders.
- 7. Bids must be duly received by the BAC Secretariat at the address below on or before July 24, 2017 @ 9:00AM. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

Bid opening shall be on July 24, 2017 @ 9:00AM at BJMP Main Conference Room, 4th Floor BJMP Building, 144 Mindanao Avenue, Project 8, Quezon City, Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

- 8. Only bidders who purchased documents would be allowed to participate in the pre-bid conference and raise or submit written queries or clarifications.
- 9. The Bureau of Jail Management and Penology, National Headquarters reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
