and

The **Pronet Systems Integrated Network Solutions, Inc** with business address at 3rd Floor Hollywood Square Building, No. 33 West Avenue, Quezon City, represented by **Ms Hannah B Gonzales**, Authorized Representative, hereinafter referred to as the “**Supplier**”.

WHEREAS, the **ENTITY** is desirous of the **Supply and Delivery of Document Scanner under the Project 3 for BJMP ISSP CY 2017 (57 Sets)** (hereinafter called “Goods”) and **ENTITY** has accepted the bid of **Nine Hundred Forty Thousand Five Hundred Pesos (Php 940,500.00)** by the **SUPPLIER** for the start of delivery of such goods within **Forty Five (45)** Calendar Days upon receipt of the Notice to Proceed (NTP).

 - f. Bid Form, including all the documents/ statements contained in the Bidders bidding envelopes as annexes;
 - g. Eligibility requirements, documents and/ or statements;
 - h. Performance Security;
 - i. Notice of Award of Contract and the bidder's conforme thereto;
 - j. Other contract documents that may be required by existing laws and/or the **ENTITY**.
 3. THAT in consideration of the payments to be made by the **ENTITY** to the **SUPPLIER** as hereinafter mentioned, the **SUPPLIER** hereby covenants with the **ENTITY** to execute and complete the delivery of Goods and remedy any defects therein in conformity with the provisions of this Contract and the relevant provisions on Obligations and Contracts (Book IV, Titles I and II) and Sales (Book IV, Title VI) of Civil Code of the Philippines;

THAT the **ENTITY** hereby covenant to pay the **SUPPLIER** in consideration of the provision of the goods and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.
