A RESOLUTION RECOMMENDING TO THE CHIEF, BJMP THE DECLARATION OF SINGLE CALCULATED AND RESPONSIVE BID AND AWARD OF CONTRACT FOR THE PROCUREMENT OF JANITORIAL AND BUILDING MAINTENANCE SERVICES TO EXCELLENT GENERAL SERVICES, INC.

WHEREAS, the procurement of janitorial and building maintenance services is essential for the well-being and cleanliness of the BJMP National Headquarters. Hence, the BJMP-NHQ have programmed this procurement, thus, included in the Annual Procurement Plan FY 2018;

WHEREAS, the Bureau of Jail Management and Penology advertised the Invitation to Bid at the PhilGEPS for the Procurement of Janitorial and Building Maintenance Services on January 17, 2018 under Bid Reference No. G-2018-002, with an Approved Budget for the Contract (ABC) amounting to **One Million Five Hundred Thousand Pesos (Php1,500,000.00)** as well as posted at the BJMP website and at the National Headquarters' Bulletin Board;

WHEREAS, the pre-procurement conference was held on January 9, 2018 at the 4th Floor, Main Conference, BJMP National Headquarters to assess the readiness of the above-mentioned project for procurement;

WHEREAS, a pre-bid conference was held on January 24, 2018 at 10:00 a.m. at the BJMP National Headquarters, 144 Mindanao Avenue, Quezon City which was attended by two (2) prospective bidders (1) Excellent General Services, Inc. and (2) Starcom Manpower and Allied Services, Inc.;

WHEREAS, prior to the Bid Opening on February 7, 2018, only Excellent General Services, Inc. submitted its bids on time;

WHEREAS, during the opening of bids on February 7, 2018 at 10:00 a.m. at the 4th Floor, Main Conference Hall, BJMP National Headquarters, the bidder passed the non-discretionary pass-fail eligibility criteria and was thus declared eligible;

WHEREAS, below is the result of the opening of its financial proposal:

WHEREAS, upon careful evaluation of the financial proposal of the bidder by the BAC through its Technical Working Group (TWG), below is the result of the Abstract of Bids as Computed:

WHEREAS, the BAC through its (TWG) proceeded with the post-qualification of the Single Calculated Bidder on February 26, 2018;

WHEREAS, upon careful examination, validation and verification of all the legal, technical and financial requirements submitted by Excellent General Services, Inc., being the Single Calculated Bidder was found to be responsive, thus, post-qualified;

NOW THEREFORE, THE BJMP Bids and Awards Committee RESOLVES, AS IT IS HEREBY RESOLVED to recommend to the Chief, BJMP:

1. To DECLARE Excellent General Services, Inc. as the bidder with the Single Calculated and Responsive Bid; and
2. To RECOMMEND that the project "Procurement of Janitorial and Building Maintenance Services" be AWARDED to Excellent General Services, Inc. with a bid amount of **One Million Four Hundred Ninety-Nine Thousand Nine Hundred Eighty-Eight Pesos and Thirty-Five Centavos (Php1,499,988.35)**.






