**A RESOLUTION RECOMMENDING TO THE CHIEF, BJMP THE DECLARATION OF LOWEST CALCULATED AND RESPONSIVE BID AND AWARD OF CONTRACT FOR THE SUPPLY AND DELIVERY OF 47, 000 ROUNDS OF .9MM CARTRIDGE (LOT 1) TO ARMSCOR SHOOTING CENTER, INC**

**WHEREAS**, the Bureau of Jail Management and Penology advertised the Invitation to Bid for the Supply and Delivery of 47,000 rounds of .9MM Cartridge (Lot 1) under BJMP ITB Reference No. G-2018-011 with a total Approved Budget for the Contract (ABC) amounting to **Php 824, 650.00**, posted in the PhilGEPS, BJMP website and at the BJMP National Headquarters Bulletin Board from August 25, 2018 to September 11, 2018;

**WHEREAS**, on September 4, 2018, the BJMP-NHQ Bids and Awards Committee held a pre-bid conference which was attended by two (2) prospective bidders namely: (1) Arm Scor Shooting Center, Inc and (2) Trust Trade ;

**WHEREAS**, the opening of bids of this project was rescheduled on September 20, 2018, though the issuance of Bid Bulletin No. 1 dated September 11, 2018;

**WHEREAS**, Arm Scor Shooting Center, Inc and Trust Trade bought the bidding documents and on September 20, 2018 – the scheduled opening of bids, dropped and submitted their bid proposal for the Supply and Delivery of 47, 000 Rounds of .9mm Cartridge;

**WHEREAS**, during the bid opening, Arm Scor Shooting Center, Inc and Trust Trade passed the non-discretionary pass-fail eligibility criteria and was declared eligible;

**WHEREAS**, below is the result of the opening and evaluation of their financial proposal:

**WHEREAS**, the BAC through its Technical Working Group, proceeded to conduct post-qualification process to Arm Scor Shooting Center, Inc;

**WHEREAS**, upon careful examination, validation and verification of all the legal, technical and financial requirements submitted by Arm Scor Shooting Center, Inc, it was found to be responsive, thus, POST-QUALIFIED;

**NOW THEREFORE, THE BJMP Bids and Awards Committee RESOLVE, AS IT IS HEREBY RESOLVED** to recommend to the Chief, BJMP the following:

1. To DECLARE Arm Scor Shooting Center, Inc as the bidder with the Lowest Calculated and Responsive Bid; and





**UNANIMOUSLY APPROVED.**






