**A RESOLUTION RECOMMENDING TO THE CHIEF, BJMP THE DECLARATION OF LOWEST CALCULATED AND RESPONSIVE BID AND AWARD OF CONTRACT**

**WHEREAS**, the Bureau of Jail Management and Penology advertised the Invitation for the Supply and Delivery of Ammunitions for CY 2017 under Bid Reference No. G-2017-032 [Lot 1: G-2017-33 Supply and Delivery of Cartridge 9mm (110,000 rds) **Php 2,310,00.00**; Lot 2: G-2017-34 Supply and Delivery of Cartridge 5.56 (72,500 rds) **Php 2,138,750.00**; Lot 3: G-2017-35 Supply and Delivery of Shot Shell 12 Gauge buck '00' (16,700 rds) **Php 551,250.00**] with a total Approved Budget for the Contract (ABC) in the amount of **Php 2,000,000.00** advertised in a newspaper of general nationwide circulation and posted the same in the PhilGEPS, BJMP website and at the Logistics Bulletin Board continuously for seven (7) days from September 19 – 26, 2017;

**WHEREAS**, on September 26, 2017 the BJMP-NHQ Bids and Awards Committee held a pre-bid conference which was attended by two (2) prospective bidders, ARMSCOR Shooting Center Inc. and Trust Trade;

**WHEREAS**, on October 9, 2017 – the scheduled opening of bids, ARMSCOR Shooting Center Inc. and Trust Trade bought the bidding documents and submitted its bid proposal for Lot 1;

**WHEREAS**, during the bid opening, the bidders ARMSCOR Shooting Center Inc. and Trust Trade both passed the non-discretionary pass-fail eligibility criteria and was thus declared eligible;

**WHEREAS**, below is the result of the opening and evaluation of its financial proposal:

**WHEREAS**, in Lot 1: Cartridge 9mm (110,000 rds), ARMSCOR Shooting Center Inc. being the Lowest Calculated Bidder has failed the product test and evaluation of ammunition;

**WHEREAS**, for Lot 1: Cartridge 9mm (110,000 rds), ARMSCOR Shooting Center Inc. was found to be not responsive thus post-disqualified;

**WHEREAS**, the BAC through its TWG proceeded with the post qualification of the next Lowest Calculated bidder the Trust Trade;

**WHEREAS**, on November 24, 2017 the BAC through its TWG conducted a Product Test and Evaluation on cartridge 9mm of Trust Trade;

**WHEREAS**, ammunition of the Trust Trade passed the Product Test and Evaluation;

**WHEREAS**, upon careful examination, validation and verification of all the eligibility/technical and financial requirements and as per the result of the Product Test and Evaluation, Trust Trade being the next Lowest Calculated Bidder was found to be responsive thus post-qualified;


**NOW THEREFORE, THE BJMP Bids and Awards Committee RESOLVES, AS IT IS HEREBY RESOLVED** to recommend to the Chief, BJMP the following:


1. To declare Trust Trade as the bidder with the Lowest Calculated and Responsive Bid for Lot 1; and
2. To recommend that the Supply and Delivery of Various Ammunitions (Lot 1) be AWARDED to Trust Trade in the amount of P 1,742,400.00.




