A RESOLUTION RECOMMENDING THE AWARD OF CONTRACT FOR THE LABOR COST FOR THE INSTALLATION OF POWER SUPPLY AND COMMISSIONING OF ONE (1) UNIT F FLOOR MOUNTED SPLIT TYPE AIR-CONDITIONING UNIT AT MESSAGE CENTER TO FIX AND CARE REF AND AIRCON REPAIR SERVICES INC.

WHEREAS, BJMP has set aside funds, as an approved Budget for the Contract (ABC), amounting to One Hundred Ninety-Four Thousand Eight Hundred Fifty Nine Pesos and 1/40 Centavos (Php 194,859.40) for the Labor Cost for the Installation of Power Supply and Commissioning of one (1) Unit of Floor Mounted Split Type Air-Conditioning Unit at Message Center;

WHEREAS, the BAC in accordance with the provisions of RA 9184 and its Revised IRR prepared and posted the Request for Quotation (RFQ) to the BJMP-NHQ Bulletin Board, PhilGEPS and BJMP Website and was sent to three (3) suppliers of known qualification;

WHEREAS, in response to said advertisements that encourages all technically, legally and financially capable supplier to participate with equal opportunity, Fix and Care Ref and Aircon Repair Services submitted their quotation with a bid amount of Php 193,000.00;


WHEREAS, the submitted quotations were evaluated and Fix and Care Ref and Aircon Services have passed on the eligibility, technical and financial requirements of the the project, hence declared as the Single Calculated and Responsive Quotation.


NOW THEREFORE, THE BJMP-NHQ BAC RESOLVED AS IT IS HEREBY RESOLVED to recommend to the Chief, BJMP the award of contract of Labor Cost for the Installation of Power Supply and Commissioning of one (1) Unit of Floor Mounted Split Type Air-Conditioning Unit at Message Center to Fix and Care Ref and Aircon Repair Services in the total amount of **One Hundred Ninety-Three Thousand Pesos (Php 193,000.00)**.

UNANIMOUSLY APPROVED.


