A RESOLUTION RECOMMENDING THE AWARD OF CONTRACT FOR THE SUPPLY, DELIVERY AND INSTALLATION OF 73 SETS OF AUTOMATIC EMERGENCY LIGHTING SYSTEM TO ENRIVEL CONSTRUCTION CORPORATION

WHEREAS, BJMP has set aside funds, as an approved Budget for the Contract (ABC), amounting to Two Hundred Twenty-Nine Thousand Eighty-Nine Pesos and 17/100 (Php 229,089.17) for the Supply, Delivery and Installation of 73 Sets of Automatic Emergency Lighting System;

WHEREAS, the BAC in accordance with the provisions of RA 9184 and its Revised IRR prepared and posted the Request for Quotation (RFQ) to the BJMP-NHQ Bulletin Board, PhilGEPS and BJMP Website and was sent to three (3) suppliers of known qualification;

WHEREAS, in response to said advertisements that encourages all technically, legally and financially capable supplier/contractor to participate with equal opportunity, Enrivel Construction Corporation and Hydrovolt Construction Services submitted their quotations.
