A RESOLUTION RECOMMENDING THE AWARD OF CONTRACT FOR THE SUPPLY AND DELIVERY OF UNINTERRUPTIBLE POWER SUPPLY (UPS) FOR THE DATA CENTER OF BJMP-NHQ

WHEREAS, the BJMP has set aside funds, as an Approved Budget for the Contract (ABC), amounting to Two Hundred Thirty-Seven Thousand Five Hundred Pesos (Php 237,500.00) for the Supply and Delivery of One (1) Unit Uninterruptible Power Supply for the Data Center of BJMP-NHQ;

WHEREAS, the aforementioned project will be procured through Negotiated – Emergency Procurement as pursuant to BJMP-BAC Resolution 2020-0016;

WHEREAS, Microgenesis Software Inc. submitted an offer amounting to Two Hundred Thirty-Four Thousand Two Hundred Pesos (Php 234,200.00) for the aforementioned project;


WHEREAS, upon confirmation and ascertainment of eligibility, technical and Financial offer of Microgenesis Software Inc. pursuant to Annex “H” of the Revised IRR of RA 9184, it was found to be eligible for the project;

NOW THEREFORE, considering the above premises, **THE BJMP-NHQ BAC RESOLVED AS IT IS HEREBY RESOLVED** to recommend to the Chief, BJMP the award of Purchase Order for the Supply and Delivery of One (1) Unit Uninterruptible Power Supply for the Data Center of BJMP-NHQ to Microgenesis Software Inc.
