**A RESOLUTION RECOMMENDING THE AWARD OF PURCHASE ORDER FOR
THE SUPPLY AND DELIVERY OF VARIOUS MEDICAL SUPPLIES TO N.S.
YAMSUAN MEDICAL AND DIAGNOSTIC SUPPLIES**

WHEREAS, BJMP has set aside funds, as an approved Budget for the Contract (ABC), amounting to Thirty Five Thousand Three Hundred Pesos (Php 35,300.00) for the purchase of various medical supplies;

WHEREAS, the aforementioned project will be procured through Negotiated – Small Value Procurement as indicated in the Annual Procurement Plan (APP) FY 2019;


WHEREAS, the BAC in accordance with the provisions of RA 9184 and its Revised IRR prepared and posted the Request for Quotation (RFQ) to the BJMP-NHQ Bulletin Board, PhilGEPS and BJMP Website and was sent to three (3) suppliers of known qualification;

WHEREAS, in response to said advertisements that encourages all technically, legally and financially capable supplier to participate with equal opportunity, only N.S. Yamsuan Medical and Diagnostic Supplies submitted a quotation.

NOW THEREFORE, THE BJMP-NHQ BAC RESOLVED AS IT IS HEREBY RESOLVED to recommend to the Chief, BJMP the award of Purchase Order for the Supply and Delivery of Various Medical Supplies to **N.S. YAMSUAN MEDICAL AND DIAGNOSTIC SUPPLIES** in the total amount **Thirty Three Thousand Three Hundred Fourteen Pesos and 20/100 (Php 33,314.20)**.
