## INVITATION TO BID (NEGOTIATED -53.1 TWO- FAILED BIDDINGS) FOR THE REPAIR OF BJMP-NHQ CY 2020

1. The **BUREAU OF JAIL MANAGEMENT AND PENOLOGY-NATIONAL HEADQUARTERS (BJMP-NHQ)**, through the **GENERAL APPROPRIATIONS ACT (GAA) FOR FY 2020** intends to apply the sum of **FOUR MILLION EIGHT HUNDRED SEVEN THOUSAND TWO HUNDRED EIGHTY-ONE AND 50/100 PESOS (PHP 4,807,281.50)** being the Approved Budget for the Contract (ABC) to payments under the contract for **REPAIR OF BJMP-NHQ 2020 UNDER BJMP-IB NO. W001-2020**.
2. The **BJMP-NHQ** invites technically, legally and financially capable contractors to bid and submit their best offer for the project under Negotiated Procurements, as allowed under the Revised Implementing Rules and Regulations of the Republic Act No. 9184.


Negotiation will be conducted on **November 24, 2020 at 9:00AM** and will cover the scope of work, technical specifications and other terms and conditions. After the negotiations, a bid bulletin will be issued in case there are items/conditions of the requirements that need to be clarified, amended or modified. 7. Best and final offers together with the eligibility requirement must be duly received by the BAC SECRETARIAT **MANUALLY** at the **BJMP-NHQ, 1ST FLOOR, MESSAGE CENTER, 144 MINDANAO AVENUE, PROJECT 8, QUEZON CITY**, on or before **December 04, 2020 at 1:00PM**. Late Offers shall not be accepted.

Opening shall be conducted on **December 04, 2020 at 1:00PM** at the **MAIN CONFERENCE ROOM, BJMP-NHQ, 144 MINDANAO AVE., PROJECT 8, QUEZON CITY** through **ZOOM (Meeting ID: 970 0710 1747 and Passcode: 655109)**. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.

Contractors shall drop their duly accomplish offer in two (2) sealed envelopes (One labeled "ORIGINAL", and one "COPY 1" with complete markings) in the designated bid box located at **BJMP-NHQ, 1ST FLOOR, MESSAGE CENTER, 144 MINDANAO AVENUE, PROJECT 8, QUEZON CITY**. Required documents are specified at Section 10 and 11 of the Instruction to Bidders.
