A RESOLUTION RECOMMENDING TO THE CHIEF, BJMP THE AWARD OF CONTRACT FOR THE SUPPLY AND DELIVERY OF UNINTERRUPTIBLE POWER SUPPLY FOR DESKTOP COMPUTERS TO LSI LEADING TECHNOLOGIES INC.

WHEREAS, BJMP has set aside funds, as an Approved Budget for the Contract (ABC), amounting to Three Hundred Ninety-Nine Thousand Two Hundred Sixty-Five Pesos (Php 399,265.00) for the Supply and Delivery of Uninterruptible Power Supply for Desktop Computers;

WHEREAS, the BJMP-NHQ BAC in accordance with the provisions of RA 9184 and its Revised IRR prepared and posted the Request for Quotation (RFQ) to the BJMP-NHQ Bulletin Board, PhilGEPS, and BJMP Website and was sent to three (3) suppliers of known qualifications, namely: (1) LSI Leading Technologies Inc.; (2) Pronet Systems Integrated Network Solution; and (3) Microgenesis;

WHEREAS, in response to said advertisements that encourages all technically, legally and financially capable supplier to participate with equal opportunity, four (4) companies submitted their quotations;
