A RESOLUTION RECOMMENDING TO THE CHIEF, BJMP THE AWARD OF CONTRACT FOR THE SUPPLY AND DELIVERY OF NINE (9) UNITS OF ANTIGEN TEST MACHINES TO VITALINE HEALTHCARE INC.

WHEREAS, the BJMP has set aside funds, as an approved Budget for the Contract (ABC), amounting to One Million Eighty Thousand Pesos (Php 1,080,000.00) for the Supply and Delivery of Nine (9) Units of Antigen Test Machine;

WHEREAS, President Rodrigo Roa Duterte declared a State of Calamity throughout the Philippines from September 13, 2020 to September 12, 2021 through Proclamation 1021 series of 2020;

WHEREAS, the BAC invited suppliers with legal, technical and financial capability by posting the Request for Quotation under Emergency Cases to the BJMP Website and BJMP Bulletin Board;

WHEREAS, Vitaline Healthcare Inc. responded to the said RFQ and was found to be responsive and compliant with the requirements set forth for the project;

NOW THEREFORE, WE the Members of the Bids and Awards Committee, hereby **RESOLVES**, as it is hereby **RESOLVED**, to recommend to the Chief, BJMP the award of contract in the total amount of Nine Hundred Thousand Pesos (Php 900,000.00) for the Supply and Delivery of Nine (9) Units of Antigen Test Machine in favor of Vitaline Healthcare Inc.


