**INVITATION TO BID FOR THE PROVISION OF
CISTERN TANK, PUMPING STATION AND
INSTALLATION OF PIPELINE AS WATER SUPPLY

1. The *Bureau of Jail Management and Penology Regional Office-CALABARZON (BJMPRO-CALABARZON)*, through the *General Appropriations Act (GAA) FY 2022* intends to apply the sum of *Two Million Eight Hundred Fifty-One Thousand Seven Hundred Seventy-One Pesos and 61/100 (P2,851,771.61)* being the Approved Budget for the Contract (ABC) to payments under the contract for the *Provision of Cistern Tank, Pumping Station and Installation of Pipeline as Water Supply System of New General Nakar District Jail (03-2022004IF)*. Bids received in excess of the ABC shall be automatically rejected at bid opening.

The *BJMPRO-CALABARZON*, through the *GAA FY 2022* intends to apply the sum of *Two Million Eight Hundred Fifty-One Thousand Seven Hundred Seventy-One Pesos and 61/100 (P2,851,771.61)* being the ABC to payments under the contract for the Provision of Cistern Tank, Pumping Station and Installation of Pipeline as Water Supply System of New General Nakar District Jail (03-2022004IF). Bids received in excess of the ABC for each lot shall be automatically rejected at bid opening.

2. The *BJMPRO-CALABARZON* now invites bids for the above Procurement Project. Completion of the Works is required *One Hundred Five (105) Calendar Days*. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
4. Interested bidders may obtain further information from *BJMPRO-CALABARZON* and inspect the Bidding Documents at the address given below from *8:00am to 5:00p.m.*
5. A complete set of Bidding Documents may be acquired by interested bidders on *February 11, 2022 to March 02, 2022* from given address and website/s below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of *Five Thousand Pesos (P5,000.00)*.

The Procuring Entity shall allow the bidder to present its proof of payment for the fees *in person, or through electronic means.*

6. The **BJMPRO-CALABARZON** will hold a Pre-Bid Conference¹ on **February 18, 2022** at **10:00a.m.** at **2nd floor Mini-Conference Room, Logistics Division, BJMP Regional Office, Brgy. Turbina, Calamba City, Laguna**, which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat through manual submission at the office address as indicated below on or before **March 02, 2022 at 01:30p.m.** Late bids shall not be accepted.
8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause 16.**
9. Bid opening shall be on **March 02, 2022 at 02:00p.m.** at the given address below. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
10. The **BJMPRO-CALABARZON** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised Implementing Rules and Regulations (IRR) of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
