## INVITATION TO BID FOR THE PROCUREMENT OF ONE (1) LOT OF VARIOUS DRUGS AND MEDICINES 01-2022-09M

1. The Bureau of Jail Management and Penology Regional Office-CALABARZON (BJMPRO-CALABARZON), through the General Appropriations Act (GAA) of the Republic of the Philippines (RA 10633) FY 2022 intends to apply the sum of Ten Million Nine Hundred Thousand Pesos (P10,900,000.00) being the ABC to payments under the contract for the Procurement of Various Drugs and Medicines 01-2022-09M. Bids received in excess of the ABC shall be automatically rejected at bid opening.

The BJMPRO-CALABARZON, through the General Appropriations Act (GAA) of the Republic of the Philippines (RA 10633) FY 2022 intends to apply the sum of Ten Million Nine Hundred Thousand Pesos (P10,900,000.00) being the ABC to payments under the contract for One (1) Lot of Various Drugs and Medicines (01-2022-09M). Bids received in excess of the ABC for each lot shall be automatically rejected at bid opening.

- 2. The *BJMPRO-CALABARZON* now invites bids for the above Procurement Project. Delivery of the Goods is required by *Five (5) days after the issuance of Notice to Proceed*. Bidders should have completed, within *Two (2) Years*, from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
- 3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
  - a. Bidding is open to all interested bidders, whether local or foreign, subject to the conditions for eligibility provided in the 2016 revised IRR of RA No. 9184.
- 4. Prospective Bidders may obtain further information from *BJMPRO-CALABARZON* and inspect the Bidding Documents at the address given below during 8:00am to 5:00p.m.

- 5. A complete set of Bidding Documents may be acquired by interested Bidders on July 20, 2022 to August 10, 2022, from the given address and website(s) below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Twenty-Five Thousand Pesos (P25,000.00). The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person, or through electronic means.
- 6. The BJMPRO-CALABARZON will hold a Pre-Bid Conference<sup>1</sup> on July 28, 2022, at 10:00a.m at 2nd floor Mini-Conference Room, Logistics Division, BJMP Regional Office, Brgy. Turbina, Calamba City, Laguna, which shall be open to prospective bidders.
- 7. Bids must be duly received by the BAC Secretariat through manual submission at the office address indicated below on or before *August 10, 2022 at 9:30a.m.* Late bids shall not be accepted.
- 8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14.
- 9. Bid opening shall be on *August 10, 2022 at 10:00a.m*. at the given address below. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
- 10. The *BJMPRO-CALABARZON* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
